

AUDIO VISUAL ROOM:



The school has latest sports facilities of both indoor and outdoor games for all age groups. It has a sports field with grassy track. The sports in school education are not just limited to physical activities as children today choose sports as their career. It has become equally essential as academic values. National Education Policy (NEP) 2020 gives special attention to sports-integrated learning for students to adopt fitness as a lifelong attitude as envisaged in the Fit India Movement.

The School encourages students to participate in games and sports like Basketball, Kho-kho, Volleyball, Handball, Skating, Badminton, Kabaddi, Judo, Races, Chess, Yoga, Rope, Skipping, Table Tennis, Martial Art, Taekwondo, etc. It has all the latest facilities with dedicated technical sports staff. In today's world, it is imperative that the students are trained not just in academics, they alone need to be prepared holistically. Our students participated in several Inter-House Competitions, Inter-District Competitions, Inter-school Competitions and outshone others and added fame to our name.

CO-CURRICULAR ACTIVITIES:

School today is no longer confined to class room instruction. We believe that school is much more than academic lessons and qualifications. Many of the most important lessons are those which students learn as part of team games, cross fertilizations of ideas, competitions and collaborative work. To pave the way for such non-cognitive learning we organize a variety of competitions and cultural events which also support formal learning. A sense of belonging and loyalty are promoted in the students by dividing them into four different houses namely, Nehru, Azad, Iqbal & Tagore. STUDENT'S PARTICIPATION:

Social leadership and responsibility are best learnt through active participation. A number of selected students appointments are entrusted with various responsibilities and share the task of maintaining the school decorum. There are School Captain, School Prefect, House Captains, House Prefect, Transport Monitors and

Class Monitors, Health Club Secretary and Eco Club Secretary. They perform duties assigned to them by the Principal over House Master/ House Mistress.

INVESTITURE CEREMONY:

Imbibing the spirit of leadership this ceremony awards badges to the future leaders, who are then expected to continue the leadership legacy. Every year, the Student Council is formed and given new duties and tasks to carry out, in order to keep the institution's flag flying high.

SYSTEM OF AWARDS:

The School has various awards for students in School, which are as follows:

SCHOOL UNIFORM:

FOR BOYS:

- 1) White Plain Terri cot (67%-33%) Shirt with tie collar, (Half sleeves in summer & full in winter).
- 2) Grey Terri cot Shorts (not more than 2 inches) above the knee in summer & Pants in winter. (for classes upto V)
- 3) Black leather shoes with laces (Bata) medium toe.
- 4) Grey Socks (as per pattern).
- 5) Necktie (as per school pattern).
- 6) Belt with school Monogram.
- 7) Grey half 'V' necked sleeveless sweater (in winter as per school pattern).
- 8) Maroon Blazer (Single Breast) with school Badge (in winter).
- 9) Maroon Patka for Sikh Boys.
- 10) Maroon Plain or self designed scarf (if required)

FOR GIRLS:

1. For Classes up to Class V White Terricot Tie collar shirt, to be worn with Grey Terri-cot Tunic and Grey Socks (as per pattern).
2. For Class VI onward Grey Terricot Shirts, White Shalwar and White Dupatta and Grey Socks (as per pattern)
3. Black leather shoes (Bata) for all the students.
4. Belt with school Monogram (up to class V).
5. Maroon Blazer (single breast) with school Badge (in winter).
6. Plain or self designed Maroon Scarf (if required).
7. Necktie up to Class V (as per school pattern).
8. Grey half 'V' necked sleeveless sweater (in winter as per school pattern).

P. T. UNIFORM:

FOR BOYS-

Half sleeved House Shirt (as per school pattern). White Shorts (not more than 2 inches above the knees) in summer and pants in winter.

FOR GIRLS-

For classes Nursery to V: Half sleeved House Shirt (as per school pattern) with white Pant.

For classes VI ONWARDS: White Shirt and White Shalwar with House coloured Dupatta.

ENTIRELY WHITE CANVAS SHOES FOR BOYS AND GIRLS BOTH.

NOTE: School uniform is compulsory. Parents are requested to ensure that their children are neat & tidy in full school uniform when they come to school.

CODE OF CONDUCT FOR STUDENTS:

- a) Our students should be polite and disciplined wherever they go. They should always remember that the school is judged by the conduct of its students. They should greet all the teachers whenever and wherever they meet them. Bullying, use of foul language and vulgar behaviour will lead to strict action.
- b) They should take good care of their health and keep themselves physically fit and strong.
- c) They should never be cruel and should know that cruelty is the trait of a bully while kindness is the mark of a gentleman.
- d) They should always accept and complete whatever work is assigned to them.
- e) They should face difficulties courageously and confidently.
- f) They should always be ready to lend a helping hand at home to their parents, brothers and sisters; in school to teachers, companions and any unattended visitor whom they happen to meet in the school premises.
- g) They should never cheat, be unfair, steal from others or borrow others' belonging without taking permission.
- h) They should stand when any teacher or visitor enters the classroom.
- i) They should respect the aesthetics of the classroom and of the school premises and report any damage caused, to the teachers.
- j) They should respect the liberty and rights of others.
- k) Instead of lamenting and grumbling over the evils of the world they should try to contribute their share in making the world a better place to live in.
- l) They should look upon people from all parts of the world and all walks of life as their brethren irrespective of their caste, colour and creed.
- m) They should not waste their time in idle gossip.
- n) They should take pride in wearing their school uniform. They should not wear the school uniform in any public place, without prior permission.
- o) Throwing things outside the window, physically hurting anyone inside the classroom, in the corridor or outside the school, throwing any object at anyone is strictly forbidden.
- p) Hair must be regularly trimmed. It must not cover the forehead or touch the collar. Girls must tie their hair in neat ponytails or plaits.
- q) Blazer is a part of the winter uniform and must be worn.
- r) The Diary and school identity card must be brought every day.
- s) Students must not litter classrooms, subject rooms, laboratories and corridors.
- t) Students need to take permission in writing to carry a camera to photograph the school activity in or outside school. They are not allowed to upload any such photograph (On the social media) any student indulging in such an activity on the social media will face disciplinary action.

MANDATORY ATTENDANCE REQUIREMENT:

Schools are not only meant for imparting subject knowledge to their students. During Schooling, Student's overall development is ensured by way of extracurricular activities, peer learning, character building, inculcation of values, collaboration, respecting diversity and inclusion, respectful interactions, teamwork and so on. Overall schools play a vital role in shaping well-rounded individuals.

Regular attendance in school is therefore important as student's presence in the school contributes to a student's academic success, personal development and overall well-being. If the students do not attend school,

their all-round development will be hampered.

A. Accordingly the board has prescribed mandatory at least 75% attendance for appearing in the examinations, 25% relaxation is given in attendance considering in emergencies faced by the students and their families.

B. In case attendance falls short, for any reason, the competent authority may take punitive action against such students, as may deemed fit, including termination of admission.

C. At least 75% attendance is compulsory for all students failing which he/she may not be eligible for promotion and may not be allowed to appear in the examinations.

D. Repeated absence without leave or in-explained absence for more than 10 consecutive days may render the student liable to have his/her name struck off the rolls. Re-admission may be granted only on the payment of fresh re-admission fee, at the discretion of the Principal/Headmistress.

E. No leave of absence is granted except on an application from parents or guardians for plausible reasons only.

In case of shortage of attendance, Parents/Guardians shall be required to procure following documents from them and submit it to the school for considering condonation of shortage of attendances:

ADMISSION PROCEDURE:

Based on the admission test and other criteria, the school reserves the right to admit students who are found fit for admission. In all matters related to admission, the management's decision will be final.

Candidate seeking admission in Classes Nursery to K. G appears for Recognition Test whereas Class I to IX & X appear for a written test and Interaction which is held to assess the subject knowledge, confidence, language, enthusiasm and emotional responses of the children.

The Age limits for seeking admission in different class are as under:

ADMISSION RULES:

- 1) Age criteria should be strictly adhered to. If the child's age does not match the age criteria of the class you cannot proceed further. Please check the age criteria provided above for selection of class.

- 6) Four latest coloured passport size photograph of student (not later than one month).
- 7) Two Group Photo of Parent & Child (2 x 3.5 inches) (not later than one month).
- 8) Community Certificate (Only in case of SC/ST/OBC.)
- 9) Single Girl Child Affidavit (Only in case of Single Girl Child).
- 10) Undertaking for Seeking Admission.
- 11) Deposit of school fees etc.

MODE OF PAYMENT:

FEE RULES:

- 1) The School fee is payable in four installments in the month of April, July, October & January; before 15th April, 15th July, 15th October & 15th January.
- 2) Fee can be deposited to the Account office of the school only through Account Payee Cheque / DD / Online bank transfer in favour of the school as mentioned on the slip. No Partial payment will be entertained, and no fee in cash will be accepted.
- 3) No out station cheques are acceptable.
- 4) If a cheque is bounced Rs. 250/- shall be charged as bank penalty.
- 5) A fine of Rs. 5/- per day will be charged as late fees upto a maximum period of 15 days from the last due date which is mentioned on the fee slip and thereafter the name of the student will be struck off from the roll.
- 6) In case the last date of the payment happens to be a Holiday, next day will be treated as last day of the payment.
- 7) In case the name being struck off, a student can be re-admitted only after the prior permission from the Principal and on the payment of Re-admission fee of Rs. 500/-
- 8) A concession of 5% on Composite Annual fee will be given, if the fee is deposited half yearly, in the month of April (up to September) and in the month of October (up to March).
- 9) A concession of 10% on Composite Annual fee will be given, if the fee is deposited annually, in the month of April (up to March).
- 10) A Sibling concession Rs. 7200/- (Annually in 4 installment equally) will be given to one child only if 3 real siblings are studying in the school.

NOTE: Concessions will be withdrawn if the fee is not deposited on time

WITHDRAWAL:

- 1) In case of seeking withdrawal, a written notice by the parents, submitted at least 90 days (3 months) in advance must be given in the office otherwise fee shall be charged for the quarter.
- 2) Transfer certificate will be issued only after obtaining a no dues certificate from different In-charges in school and depositing a fee of Rs. 200/-.
- 3) The Transfer Certificate is issued after 10 days from the date of receipt of the Application.
- 4) The Caution Money not claimed upto three (3) years from the date of notice of withdrawal, will be forfeited.

SUSPENSION / DISMISSAL:

A student may be detained / suspended / barred from examinations or tests / dismissed from the school at the discretion of the Principal/ Headmistress under the following grounds.

- Disciplinary
- Unsatisfactory progress in work
- Detention or repeated detention in a class.
- A child failing twice in the same class will not be permitted to continue his/her studies in the school.

- Any other ground that the Principal/Headmistress deems necessary/ appropriate in the interest of the school and its students.

GENERAL RULES:
